
## ALTERNATIVE MEASURES AND EXTRAJUDICIAL SANCTIONS AGENCIES (SK)

  providing victims, communities and offenders with the opportunity to address their needs in a

- These programs work with adult and youth offenders, victims and community representatives to address harm caused by offending behaviour through compensation, restitution, counselling and community service.

#### **PROGRAM DESCRIPTION:**

Services: Alternative measures programs for adults, Extra-judicial measures for youth, and public education and crime prevention initiatives.

The program uses a restorative approach to diverting offenders away from the mainstream justice system to more culturally appropriate community-based alternatives, where appropriate. Through this process the community has the opportunity to work collaboratively to address the effects of the crime, to repair the harm, address some of the root causes of the crime and, ultimately, to improve community safety and wellness. Diverting offenders away from the mainstream justice system is a discretionary tool used by police and prosecutors, with the consent of communities, for offences they view as more appropriate for out-of-court resolution. Generally speaking, this involves lesser offences.

For all of these initiatives, the ACTC Community Program staff work in close partnership with elders, community justice committees and other agencies as necessary to provide relevant and meaningful community justice services. Other agencies the Program engages in its work include the National Native Alcohol and Drug Abuse Program, Social Development, Fine Options, Courtworkers and Health Services.

#### Services provided:

The Justice Team will focus on the effective, just and humane response to crime and it's causes by providing for the effective integration into the community of those in conflict of the law. Will also provide services to those in contact with, or affected by the criminal justice system, and promote changes in the law and the administration of justice which will lead to more humane and effective treatment of our members. The justice program will also promote awareness of the problems and involvements in the delivery of management of justice-related programs. The Justice Team will promote and ensure of fair and humane treatment of its incarcerated persons and will work to ensure that all forms of detention and imprisonment comply with legal and human rights standards. The Program develops and delivers alternative measures and intensive case management for adults and youth through a Community Justice Committee and a Justice Worker. The Program's activities include public education, crime prevention, healing and sentencing circles, and community based support programs for offenders. (*Government of Canada*)

#### **PROGRAM DESCRIPTION**

#### **Restorative Justice Unit:**

The services include:

- **Probation:** As officers of the court they supervise the court orders in our communities.
- Youth Reintegration: As a community liaison between youth released from court and their community resources.

- **Courtworker:** As liaisons between the court and the community they offer insight into the workings of the courts, court terminology and give direction to clients to obtain legal aid.
- **Community Justice:** The Officers meet with the justice committees, arrange justice gatherings, provide circle facilitation, mediation, trainings.

The program is called restorative due to the nature of our programming. Restorative being defined as the restoration of a person's balance, spiritually, mentally, physically and emotionally. Restorative justice emphasizes repairing the harm caused by crime. When those that are hurt and those doing the harm meet to decide how to do that, the results can be transformational. #### **PROGRAM DESCRIPTION:**

Alternative Measures refers to means other than the formal court process for adults charged with certain offenses as approved by the Ministry of Justice and the Crown Prosecutor. In order for an offense to be eligible for referral to the program, adults are required to take responsibility for committing the offense. Program staff arrange a face-to-face meeting between offender and victim. A mediated discussion takes place with the intent of repairing harm and deterring the offender from further criminal activity. The goal is to address underlying issues and focus on education and information. Upon successful completion, the charge is withdrawn in court. The program is centered on the belief that justice is best determined by those directly involved. (John Howard Society Moose Jaw, AMS/EJS Pamphlet)

#### **PROGRAM DESCRIPTION:**

The Alternative Measures Program is a community Justice Program developed and delivered by Saskatchewan Justice, Corrections and Public Safety and the Aboriginal Justice Directorate. The La Loche

Alternative Measures/Extrajudicial Sanctions Program works with youth and adult offenders who come into conflict with the law.

Alternative Measures is a program that diverts offenders away from attaining criminal records. AMP provides avenue for victims for possible reconciliation, restitution and restoration of peace and harmony.

Alternative Measures include different options and is dependent upon each case. Possible Alternative Measures can include:

**1.** Victim/Offender Mediation Services are the heart of the reconciliation process. In that meeting, a third neutral party, a mediator facilitates the sharing of facts, feelings and concerns of both parties.

**2.** Multi-party Conferences are meetings, in which the victim, the offender, people who attend to support the victim or the offender, and members of the community meet to work out an agreement that satisfies the victim, meets the needs of the offender and gives members of the community a role in helping both parties. More specifically, AMP can arrange a 'Family Group Conference' or 'Community Accountability Forums' if the case involves young offenders and their families, or 'Community Justice Forums' if they involve adults.

Alternative Measures Program offers referrals to counseling, guidance and support services for clients as needed. Alternative Measures Program keeps in touch with clients and informs everyone concerned, including Police and the Crown, with respect to the outcomes of the agreements and completions. The objectives of the Program are to provide community based services related to crime prevention, public education, dispute resolution/peacekeeping and alternative measures including diversion, healing circles, family group conferencing and support programming for youth and adults in contact with the mainstream justice system. MLTC encompasses a holistic view of the Justice system in First Nation Governments and works towards building a healthy community and lowering recidivism rates. Each of the MLFN's house a Justice Coordinator who provides direct services to the community in which they reside. The Justice Coordinators are responsible for all mediation files, fine options plans, court appearances, and other justice initiatives within their communities. We at MLTC provide advice and direction to the Justice Coordinators on the development and implementation of community justice structures, plans and services; and works to serve as a liaison with the FSIN Indian Justice Council, the Federal and Provincial Governments and Justice sector officials. The Justice program at MLTC invests in people and their future. With the guidance of our Elders we strive towards building stronger communities, safer communities, and healthier communities. The MLTC justice staff is dedicated to the principals of restorative Justice and works effectively and arduously to bring these initiatives to the 9 MLFN's. The MLTC Justice program works in conjunction with the MLFN's to ensure Justice Programs are educational, we work in creating awareness, and provide training and partnerships with these communities to provide assistance, guidance, and delivery of community based justice initiatives. The Program coordinates the development of community justice structures, plans and services for nine member First Nations. Activities vary from community to community and include crime prevention; mediation and dispute resolution; healing, talking and sentencing circles; alternative measures programs for adults and youth; victim services; and community based correctional services that focus on offender rehabilitation and reintegration, and victim/offender healing. #### **PROGRAM DESCRIPTION:**

#### **Onion Lake Native Justice**

- Community mediation: aimed at improving communication between disputants and to help the parties reach an agreement.
- Court-worker program: delivers services to one court point Onion Lake to both Aboriginal and non-Aboriginal people involved in the court system.
- Fine-option program: an alternative to those who cannot meet the fines levied upon them by the court.
- Youth-prevention program: provides intensive supervision for medium to high-risk young offenders to assist them with successful completion of probation or as a support for those in custody.
- Reintegration program: developed to provide Aboriginal communities a greater role in planning for the institutional release -of membership back into their communities.
- Alternative-measures program: emphasizes on the offender taking responsibility for their actions, and also promoting empathy for the victim(s) reparation and prevention of future harm.
- Youth justice committee: offers young people a place in the community to address justice issues within our nation among other youth. (Program is on hold until further notice).
- Hub committee: a collaboration between various departments in an effort to proactively address issues that are identified as a crisis with an elevated level of risk.
- Drug strategy: an all-inclusive approach for Onion Lake First Nation based on prevention, harm reduction, treatment and enforcement. The foundation is based on cultural, customary and natural laws. (*Onion Lake Cree Nation, Native Justice*)

#### **PROGRAM DESCRIPTION:**

The Pasquia Hills Community Justice Committee is committed to dealing with crime in the area. Offenders are offered alternative measures either by their own request or through the petition of the courts or the police. The committee focuses on victim/offender mediation in a unique resolution processes in the Carrot River, Zenon Park and Arborfield region of Saskatchewan. Local facilitators are paired with a committee members to review cases that involve young offenders. The Pasquia Hills Community Justice Committee seeks to involve various stakeholders by rotating its monthly meetings throughout the three communities

involved. The Pasquia Hills Community Justice Committee accepts all individuals during any stage of the criminal justice process to make use of their resources. (*Government of Canada*)

Alternative Measures refers to programs in which adults and youths who are accused of a criminal offense take responsibility for their behavior by participating in a community based program. These programs adapt to balance the need of victims, the accused and their communities while ensuring that society is protected. They make the accused person take responsibility for their behavior and to address the harm they have committed. Alternative Measures are a way to address crime in conjunction with the present criminal justice system. These programs address the criminal actions of the accused while preserving their dignity and requiring them to be accountable for their behavior. It attempts to make things right by taking a problem solving approach to crime, which emphasizes forgiveness and healing while helping to repair relationships between the victim, the accused and the community. A person who is referred to and chooses to participate in the Alternative Measures Program must admit responsibility for the offense. A meeting is then arranged between the victim, the offender and the community members. Each is given an opportunity to express their thoughts and feelings with respect to the offense and with the assistance of a mediator, come to an agreement which each believes is fair. The agreement could involve the offender doing volunteer work for the victim or the community, paying the victim for the damage caused, attending counseling, or any other activity acceptable to all parties. This process often leads to the restoration of harmony between the victim and the offender. (Carrot River, Emergency Services)

## URBAN ALTERNATIVE MEASURES

The Prince Albert Urban Alternative Measures Program is a community based program that diverts offenders away from the formal justice system. The program receives referrals pre-charge (from police, community members) and post-charge (Provincial/Federal prosecution office, RCMP).

PAUAMP offers Victim/Offender Mediation, Family Group Conferencing, School Mediation, Adult/Youth stop-lift program, Community Justice Forums and Accountability Hearings.

This year AMP staff attended Surrogate Victim Training, Native Family Systems Training, Community Action Against Crystal Meth Conference and Victim Offender Mediation – Train the Trainer.

AMP staff conducted Surrogate Victim Training; which included an AMP Overview, Communication Skills, SV Roles and Responsibilities, and Victim Needs/Sensitivity. The Surrogate Victims will be utilized when victims are unable to attend mediation. The use of surrogate victims increases the accountability of the offender to the victim and creates a greater understanding of the effects actions have not only on the individual person that they have violated but the community.

AMP provided 3 Youth Day Programs, which included topics on life in prison, talking circles, positive relationships, and family violence. (*PAGC Justice Programs*)

#### **PROGRAM DESCRIPTION:**

The focus of the Program is on victims' healing and the rehabilitation of offenders using mediation, family group conferencing and healing circles that are culturally relevant to the First Nation and Métis populations of Regina. The Program also delivers community education and public awareness workshops, and works to develop appropriate processes and protocols for ongoing community involvement. As well, the Program

conducts educational sessions in schools and also trains the Regina Police Service and the Royal Canadian Mounted Police. (*Government of Canada*)

If all parties (Victim and Offender) agree to participate, RAMP will then assess the case and determine which of the program options would best suit the needs of the victim and the offender. Some of the RAMP options include:

## Victim/Offender Mediation:

• The victim and the accused person meet with a trained facilitator. (<u>RAMP Program Options</u>)

#### Stop-Lift Program:

• The Stop-Lift Program was developed for referrals that deal with charges in connection with shoplifting and thefts of goods from retail stores. Specific cases of fraud, such as "price tag switching" are also referred to the Stop-Lift Program. The program consists of the accused completing four community service hours at an agency prior to attending the Stop-Left Educational Program. The educational program is approximately four hours in length and is facilitated by a RAMP facilitator. RAMP invites presenters from a variety of community organizations to discuss the impacts of shoplifting. Speakers include: A police officer, loss-prevention officer, a community member and an elder. Lastly, a letter of experience is to be submitted to RAMP by the offender. This letter is forwarded to the retail store where the offence occurred. (*RAMP Program Options*)

#### **Community Justice Circles:**

"Circles" are a generic name for processes to resolve a conflict or issue between an offender, a victim(s), and/or community members. Circles usually involve the accused, the victim, a facilitator, and a wide range of individuals such as family supports, community members, professionals, and others. (*RAMP Program Options*)

#### **Community Justice Forums:**

• The victims(s), the accused person(s), and other community members who are relevant to the case meet with a trained facilitator. (*RAMP Program Options*)

#### **STC Justice Services:**

The objective of the STC Justice Program is to provide wrap-around support to youth, adults, and their families in a restorative justice approach. This wrap-around support is delivered through an indigenized case management process. The STC Justice Program is open to all individuals referred to us with eligible criminal charges.

The goal of the STC Justice Program is to ultimately improve the quality of life of our Indigenous Relatives while restoring individual, family, and community relationships. We achieve this by working in collaboration with our Justice and community partners. #### URBAN JUSTICE PROGRAM DESCRIPTION

#### **Alternative Measures and Extrajudicial Sanctions:**

The program is referral-based for adults and youth. Alternative measures/extrajudicial sanctions
programs provide effective, efficient ways of resolving disputes that involve communities in
developing culturally sensitive services to promote healing and reparation. They are also a way to
address crime in conjunction with the criminal justice system. (*STC, Urban Justice Programs*)

#### **Opikinawasowin (Reintegration) Program:**

The program is referral-based for ages 12-24. Program mentors support and link youth and young
adults to resources and support networks within the community. The program is designed to
support and assist Relatives in accessing appropriate rehabilitative services to reduce the risk of
gang involvement and re-offending. (<u>STC, Urban Justice Programs</u>)

## Indigenous Court Worker Program:

 Court Workers provide information to Relatives in and out of custody and offer information on their charges and options. The Court Workers also offer resources/ information that will assist Relatives in making an informed decision. Court Workers will appear on behalf of a Relative if an emergency arises. This service is only offered if given 24 hours' notice. (*STC, Urban Justice Programs*)

## Reintegration at Saskatoon Correctional Centre (SCC) (Pilot Project):

 Referrals come from the Saskatoon Correctional. Pilot Project formed in 2020 that works with Relatives in the SCC Urban Camp, Men's and Women's Reintegration Units. The program's goal is to guide our Relatives in a wrap-around holistic approach and connect them to services such as housing, education, employment, mental health, addictions, culture, etc. (*STC, Urban Justice Programs*)

#### **PROGRAM DESCRIPTION:**

Restorative Justice is simply a different way of thinking about a crime and our response to deal with law breakers. We often view crime as a crime against the crown and when the law is broken it is the Crowns responsibility to deal with the offenders. Under the Restorative Justice Model, crime is viewed as an offence that breaks the relationship between individuals. They feel that First Nations and communities are in the better position to deal with the offenders than the Crown. (*Touchwood Agency, Justice*)

The Program delivers alternative measures programming for youth and adults that are grounded in traditional First Nations values, beliefs and methods of dispute resolution. Elders and Community Justice Committees in each of the four member First Nations organize, guide and direct community justice activities. These activities include crime prevention; early intervention; healing, talking and sentencing circles; mediation and dispute resolution; alternative measures programs for adults and youth; victims services; and community based correctional services that focus on offender rehabilitation and reintegration, and victim/offender healing. (*Government of Canada*)

#### **PROGRAM DESCRIPTION:**

For adult offenders AMP contacts the accused and victim in the case and coordinates/facilitates a mediation meeting. If the victim is not interested in taking part directly, he or she may appoint a representative to act on his/her behalf. In some cases the agency proceeds with the matter without the direct participation of the victim or a victim representative. The agency will appoint a surrogate victim in these matters. (*Yorkton Tribal Council, Justice*)

Through mediation, the accused explains his/her involvement in the offense and gives the victim the opportunity to express how the crime affected him/her. Once the feelings and concerns of the parties are explored and dealt with, then an agreement for settlement is sought. (*Yorkton Tribal Council, Justice*)

In cases where the victim does not wish to participate or appoint a representative the matter can still proceed. This process is a separate form of diversion where AMP uses a surrogate victim or agency representative to deal with the matter. (*Yorkton Tribal Council, Justice*)

With respect to youths, the same process is undertaken, except parents are notified and encouraged to participate. In some cases, as deemed appropriate by the AMP agency, certain young offenders will be processed through a process of Family Group/Community Accountability Conferencing. Though this process victims, offenders and significant others, such as extended family and community members who have an interest in the outcome, and/or are affected by the crime, are provided an opportunity to meet and attend to the material and emotional effects resulting from and relating to the incident. With respect to on-reserve First Nation members, the same process is undertaken, except that the First Nation Justice Committee is notified and encouraged to participate. (*Yorkton Tribal Council, Justice*)
